Programme

The Mediterranean has become the focus of migration related discussions, too often presented as a challenge or burden. Going against this current, the Mediterranean City-to-City Migration (MC2CM) initiative has, since 2015, sought to highlight the positive aspects of migration. It gathered evidence, catalogued good practices, and promoted partnerships that link migration to urban development in the Mediterranean.

Funded by the European Union and the Swiss Agency for Development and Cooperation, and implemented by the International Centre for Migration Policy Development (ICMPD) in partnership with United Cities and Local Governments (UCLG) and UN-Habitat, this project contributes to enhanced local migration governance.

This high-level event will give Mayors, national representatives and experts the opportunity to discuss the findings, and recommendations of the MC2CM. Subsequently a way forward to the next phase will be paved, in which cities will leverage their unique role to enhance the benefits of migration, at the local and national level.






